The Pennsylvania Department of Transportation (PennDOT) invites you to participate in public meetings to review new improvement alternatives for the **Western Terminus/PA Route 10 Project Area in Sadsbury and West Sadsbury Townships in Chester County**. The Western Terminus/PA Route 10 Project Area (Section 10) is one of a series of projects that will upgrade and reconstruct the US 30 Bypass in Chester County.

The project team will give a 30-minute presentation, followed by a question and answer period.
